Vendor Management and TPAs

Historically, insurance companies managed their vendors as an operational concern, to ensure that business ran smoothly and customers were served. Today, however, "vendor management" is increasingly becoming just as much a compliance issue. Regulators are demanding that insurance companies thoroughly diligence their suppliers, contract for proper protections and perform ongoing oversight and management – with significant consequences for companies that are not taking the necessary steps. Life Insurance Distribution: Broken, Fractured, or Evolving?

Large forces continue to influence the distribution of life insurance in the United States including globalization, technology, and demographics. Traditional producers are aging and retiring. Who will replace these distributors and will they rely upon traditional sales models? Will a new consumer driven generation of buyers demand new ways of buying insurance? Captive or closely aligned distribution channels require significant cost and time investment and face pressure from independents and alternative distribution channels. Independent distributors through IMOs or regional firms continue to control a large portion of life sales. Large carriers are increasingly exploring direct sales through technology enabled and on-line sales processes. Innovative technology firms seek to disrupt traditional distribution through B2B2C or D2C digital models with automatic underwriting models. Large and regional intermediaries (banks, broker dealers and investment advisors) are also expanding product portfolios to include insurance products sold on a low or levelized commission or on a fee basis. Alternative distribution channels, such as property/casualty distributors, are also evaluating or being encouraged by insurers to include life products. This panel of insurance industry experts will discuss the trends and debate the future direction of life insurance distribution.
