This Savannah experience begins with lunch at the Olde Pink House. It's one of Savannah's most popular restaurant, offering new southern cuisine in a sophisticated, yet casual setting. The building is a fine example of colonial architecture, one of the few buildings to survive the fire of 1796 and is the site of many secret meetings which helped to secure the independence of the 13 colonies from England.



The experience continues with a trolley ride through historic Savannah,

touring one of Savannah's Historic House Museums offering a look into the lives of some of the city's wealthy cotton merchants. The tour continues with a visit to The Cathedral of St. John the Baptist (based on availability) which is compared to some of the most beautiful churches in Europe.
